

The meeting was called to order at 7:03 PM October 10, 2020.

21 attendees introduced themselves.

The most recent minutes were read. Rich W3ACO moved acceptance and WØQC seconded. Motion passed.

Mike NA9Q presented treasury activity for April-Sep 2025. He notes that EIDX is changing accounting to a calendar year basis. Expenditures are in line with estimates. Many have paid ahead on dues which will affect cash flow going forward. Dues paid this evening will be applied to 2026.

Gary Hill AAØCL applied for associate membership. Terry WØAWL moved acceptance. Jim WØSR seconded. Passed.

Bob WØGXA is retiring after many years of editing the excellent EIDX newsletter. No replacement has been named and anyone interested in the post is encouraged to come forward. It was questioned if groups.io and the website could replace the newsletter. Members will be polled for their opinions.

There are no outstanding requests for DXpedition funding.

Terry WØAWL moved we appoint Ron NØSL as our new station trustee for NØDX. Tom WØWP seconded. Passed. Ron is gathering the necessary documentation for submission to ARRL VEC. An email address (eidxa@gmail.com) will be established for the application and also for the use of EIDX officers.

Gary AAØCL spoke on the statistics he has been gathering on member activity. His system does not capture totals less than 100. Those with less than 100 will have to compile the numbers themselves and submit the results to Gary. The intention is to post the results on the website with either quarterly or semiannual updates.
